Workpaper: Phase 2 (i) Forensic Review

1. Purpose

The purpose of this workbook is to conduct a review of the all legal entities associated with Crown's Australian casino operations (as identified by Crown) and identify whether additional legal entities may hold bank accounts that are or were capable of being used by patrons to deposit or withdraw funds during the three year period 22 February 2018 to 22 February 2021. Any such legal entities would be included as Relevant Crown Entities.

2. Scope

In accordance with our signed engagement letter dated 22 February 2021, we have conducted our procedures in accordance with our agreed scope of work

Agreed Scope of Work - Engagement Letter

- i) Preliminary assessment of Crown's legal entities and bank account
 - a. Obtain a list from Crown of all legal entities and their domestic and international bank accounts associated with Crown's Australian casino operations. Based on this list and discussions with Crown representatives (yet to be identified), seek to establish understanding of the nature of purpose of each entity and bank account.
 - b. Where possible, verify (using external data sources) the completeness of the Crown entity list.
 - c. Document outcomes of review, including specific identification of all legal entities and bank accounts that are or were capable of being used by patrons to deposit or withdraw funds during the Relevant Period.
 - d. With respect to accounts not deemed to be capable of being used by patrons to deposit or withdraw funds during the Relevant Period, undertake a sample based review of the transactional activity within a non-statistical sample of these accounts (by category or grouping of nature and purpose) to test.
 - e. Document all legal entities and bank accounts identified as in scope for the purposes of the Forensic Review and Further Controls Assessment.

Our procedures are limited to the following conditions:

- The period 22 February 2014 to 22 February 2021(the Period)
- Crown Resorts Limited's Australian operations
- The procedures are limited to the legal entities identified in Table 1.1.

3. Background

Crown Resorts Limited (Crown) is a public company listed on the Australian Stock Exchange (ASX). Crown operates "integrated resorts" in Melbourne and Perth featuring "luxury accommodation and award-winning dining, world class gaming, conferencing, shopping and entertainment facilities"¹. A casino is integrated into each of the resorts, Crown Melbourne and Crown Perth, the licensing and operations of which are subject to regulation by statutory authorities in Victoria and Western Australia respectively².

4. Methodology

Our procedures to establish known and unknown legal entities of Crown Australian entities in accordance with our agreed scope of work included the following:

- **Step 1** Obtain a list from Crown of all legal entities and their domestic and international bank accounts associated with Crown's Australian casino operations.
- Step 2 Establish an understanding of the nature of purpose of each entity and bank account.
- **Step 3 -** Identify the group structure and publically published entities of Crown Resorts Limited (Parent entity) as publically disclosed in the Annual Reports over the Period and through searches performed on Company 360, D&B Hoovers, Illion Direct and Infotrack
- **Step 4** Identify past and current Directors and Senior Management team of the known entities identified in **Table 1.1** from publically available sources including the published Annual Report of Crown Resorts Limited, the relevant entity website and company searches performed through one or more of the following:
 - a. Company 360
 - b. D&B Hoovers
 - c. Illion Direct
 - d. InfoTrack.
- **Step 5** In relation to each Director and Senior Management identified, identify a list of all entities in which they hold another Director or Senior Management position through person searches performed through one or more of the following:
 - e. Company 360
 - f. D&B Hoovers
 - g. Illion Direct
 - h. InfoTrack.
- Step 6 For all entities identified in step 3, determine if the entity is:
 - i. Analysis 1: Known to the Crown and part of the Crown Group as identified in:
 - i. the Crown Resorts Limited Annual Report over the Period
 - ii. Table 1.2

If Analysis 1 is a PASS, then Analysis 2 defaults to N/A

- j. Analysis 2: If the entity is unknown to the Crown Group:
 - i. Determine whether the Crown Group has an ownership interest in the entity.
 - 1. Perform a search for the entity on Company 360/ D&B Hoovers / Illion Direct / Infotrack and access the Family Tree/Corporate Tree function. Where a known Crown entity is part of the Family/Corporate Tree, a relationship to the Crown Group was established and concluded to be unknown to Crown.

ii. In addition, we performed a search of the entity to identify if it appeared to operate a business / operate as described in Company 360 / D&B Hoovers /Illion Direct.

Step 7 - For all entities failing Analysis 2 in Step 4, seek further clarification from Crown.

5. Conclusion

EL SOW Phase 2 (i) a, b, c

We performed the above procedures, as outlined below. These procedures did not result in the identification of any entities unknown to Crown. The results of the analysis are outlined below:

- (a) Step 1 identified 33 legal entities which could potentially hold a domestically and/or domestic internal bank account associated with Crown's Australian casino operations, which had not been provided to us. Crown's response to the 33 legal entities are below:
 - 27 legal entities with no bank accounts
 - o 2 legal entities which had a bank account used for non-gaming activities e.g. payroll
 - 4 legal entities part of a JV or minority shareholding and no bank accounts for Australian operations.
- (b)-(c) Step 1-4 applied external data sources to identify the completeness of the legal entities identified in Step 1. We identified 22 legal entities which required clarification from Crown. Of the 22 legal entities Crown confirmed:
 - o 19 did not undertake gambling operations and did not have a bank account
 - 2 were confirmed to be CPH entities
 - 1 Crown Lotto Pty Ltd was identified as a known entity to Crown. However, Crown were unsure bank accounts existed for this entity or whether CrownBet customers had the ability to deposit funds.

The procedures performed did not result in the identification of any entities unknown to Crown.

Findings

Step 1 | Obtain a list from Crown of all legal entities and their domestic and international bank accounts associated with Crown's Australian casino operations

Step 2 | Establish a nature and purpose for each Crown bank account

Our analysis performed in a separate workpaper found here identified 167 bank accounts which were in scope for the purpose of our review (including both patron and non-patron transactions)

Step 3 | Identify Group Structure

Based on the information obtained in Step 1, we were provided the bank accounts in existence since 2014. Therefore, on this basis, the below entities are known to Crown as at \overline{X}

Consolidated Press Holdings Pty Limited (CPH) is the local holding company for the Packer family's diverse investments and business interests. Its most notable investment is its majority shareholding in casino group Crown Resorts Limited.

Consolidated Press International Holdings Limited Bahamas is the parent company of CPH.3

Therefore, any entities within the above analysis are supposed to be known by Crown.

Step 4 | Identification of Directors and Senior Management

We performed a search of publically available sources to identify the Directors and Senior Management of the known legal entities operating casinos within Australia over the Period.

In addition, we have included Crown Resorts Limited within our analysis as this is the legal parent of all the Crown entities and has 100% control of all the entities to be addressed.

Step 5 & 6 | Director Search Results

Based on the Directors and Senior Management identified within Table 1.3, we performed a company search using Company 360, D&B Hoovers, Illion Direct and Infotrack to identify the other entities in which they were a Director, Company Secretary or within Senior Management. This was performed for all 34 unique past and current directors and senior management of the relevant entities.

As outlined in our methodology, this included performing *analysis 1* (entity known to Crown) and *analysis 2* (entity owned by Crown).
