

LACHLAN MOFFET GRAY THE AUSTRALIAN 30/03/2021 9:26AM	Given the prevalence responsible gaming at Crown Melbourne will be afforded at the Royal Commission, I thought I might ask a few questions about recommendations relating to the subject made by the VCGLR in their last five year review.	
	I understand now is a busy time for you all, so I hope these questions do not require too much digging. Would it be possible to get a response today?	
	Can Crown provide breaches of voluntary exclusion figures for 2018 and 2019?	
	The VCGLR recommended Crown Melbourne " review its	

allocation of staffing resources to increase the number of work hours actually available to responsible gambling and intervention with patrons" by January 1 2020. Has this been completed?

- 3. Crown's August 2015 play periods policy indicated that RGSC staff intervened after 16 or 24 hours of loyalty member play and implied this policy was too conservative. Has it been modified since?
- 4. Recommendation 8 states: "Crown Melbourne will, by 1 January 2019, commence a comprehensive study of all the practical options for a real time player data analytics tool, with a view to reporting in detail (including legal, technical and methodological issues) to the VCGLR by 1 January 2020 and the tool being in operation by 1 July 2022." Has this detailed report been made and is the tool set to begin operation next year?
- 5. The VCGLR recommended that "by 1 July 2019, Crown Melbourne rebrand or refresh its responsible gambling messaging and publish new responsible gambling messages throughout the casino, in all Crown Melbourne publications, including online and social media platforms." Has this been achieved?
- 6. In line with recommendation 8, has Crown reviewed its policy for voluntary exclusion orders by 1 July 2019, and has it implemented the recommended policies of "short term exclusion orders for three, six, 12 or 24 months under section 72 of the Casino Control Act"
