We refer to the following exchange between Commissioner Finkelstein and Mr Borksy QC, Counsel for Crown, at transcript reference T1721 to T1722:

MR BORSKY: Thank you. I'm grateful for that indication, and to be transparent with you, Commissioner, from discussions I've had with my learned friend Mr Finanzio in recent days, at least from Counsel Assisting's perspective, there is no difficulty with us writing to the Commission and seeking to tender some documents on issues that arise from time to time, rather than having every document tendered through a witness. Royal Commission into the Casino Operator and Licence Request for further information regarding Crown Melbourne visitation

I refer to evidence before the Royal Commission regarding casino visitation numbers, and in particular my evidence on 4 June 2021. I have conducted some further work to provide some additional information on this topic.

As discussed during the hearing, the number of unique Crown Rewards members who visit in a day averaged 7,859 in FY19.

Many Crown Rewards members visit Crown Melbourne on multiple days each year. Consequently, the total number of unique Crown Rewards members that visited the Crown Melbourne Casino during FY19 is 230,691.

To assist the Commission, a summary of the number of unique Crown Rewards members who visited in financial years FY16 to FY21 is provided below:

Fiscal Year	Number of Active Unique Crown Rewards Members
F16	248,731
F17	250,872
F18	239,378
F19	230,691
F20	203,209
F21 ¹	83,205

Unfortunately, Crown is not able to use this information to estimate the total unique customer figure (as it has for the daily numbers), as data available does not allow us to reasonably estimate the visit frequency of patrons who are not Crown Rewards members.
