

19:40 - B2 Vegas Disabled pathway:

Area checked and found to be clear of hazards and spillages. I did notice that there was a small amount water forming around one of the holes in the corridor wall. This was monitored throughout the shift.

20:05 - Other Incidents:

I received a call from Acting Pit Boss Kirsten at Pit 10 informing that she had been approached by a non-English speaking Greek patron who presented her with a business card of attended shortly after met with S&S Officer Arthur #75 who was conversing with the patron in Greek; he stated that the patron was complaining about another patron who was swearing in Greek whilst playing at the gaming table that they were both playing at, she told Arthur that she took offence to his language and became in argument with him.

DSS Mo informed me that the male in question had been spoken to regarding his language usage and he agreed to curb his behaviour. I approached the patron under SV coverage and discussed the incident, I asked him if he had been swearing at the table due to gambling becoming a problem, he stated that he had been losing and had become frustrated by this, when asked if he the CCSC could assist him he gave thanks for the concern and said that he didn't have a problem.

I asked S&S Officer Arthur to confirm my questions to the male in Greek; he told Arthur that he would speak to S&S Officer Angelo with regard to any gambling problems that arise and if further advised by Angelo #181 he would speak to the RGLO duty if any problems arose.



01:55 - Other Incidents:

I received a call from Comms Operator Tania informing that I had been requested by TG staff to attend Pit 17 for a distressed Female. Upon arrival I spoke with Pit Boss Rebecca who pointed out the female in question and identified her as Personal Rebecca explained that Pers been involved in an argument between two other patrons regarding a money lending issue. Pers had stated that the man she was arguing with had loaned her money a few days ago and that she had repaid the loan yesterday. Rebecca told me that Pers started crying and said that she had lost so much money and all of her diamonds because of her gambling. The male was identified as Personal

Once all parties had separated from the table I approached Pers and asked to speak to her, she said "I don't want to talk", a friend next to her then said to me "she don't want" and gestured to me that I go away. I moved away from the table and approached the front of the Teak room where Person beverage was talking to Personal he denied that he had lent money to Person but admitted that he had been involved in an argument with her because he had witnessed her borrow money from another male on Monday and he was not happy with Person claim that the money had been repaid.

Persona informed Person that money lending would not be tolerated at Crown and that if he was found to be involved in money lending, he would not be welcome back again.





02:40 - Police/Human Services:

I received call Comms Operator Steve requesting that I attend the front of "Barcode" for a group of 3 minors. I attended shortly after and recognised one of the males as Personal (under care of DHS), one of the male stated that he was 18 and the other stated that he was 14 and also under the care of DHS, I explained to the group that they should be with their cares, they said they were bored didn't want to go home. Whilst trying to keep the group together I attempted to make contact with DHS after hours but was unsuccessful, I then requested that Comms call Vic Pol to confirm if Personal an outstanding Warrant. I tried to encourage the Group into the CCSC but Personal refused despite his friends supporting the idea. Personal "you can't keep me here, I know you can't" he then said that he was leaving and headed out to western entry with the other 2 males.

I managed to stall Perso for a few more moments as I was informed by Comms that Vic Pol were on their way, but the group departed north along Clarendon Street before they could arrive. A few minutes later a Vic Pol unit arrived at western entry, asked for the group's direction of travel and exited the area.

I received a call from Central Crown Club requesting that I attend for a patron wishing to be Self-excluded. I attended shortly after and met with the patron who introduced himself as I escorted to the CCSC and along the way he explained that he was in debt of \$4000 on Credit card and wanted to be Self-excluded before his situation got out of hand. I began to explain the S/E process to Perso and half way through he interrupted me and apologised for taking up my time, he then said that he wanted a day to think things over and stated that he would come back to the CCSC tomorrow. Before made a hasty exit from CCSC I reminded him of the issues that he described to me earlier. Chubb Officer Jamil was present at the event.
