

was then approached near Kings Buffet Exit from the gaming floor and informed that his behaviour was unacceptable and escorted peacefully off the property by SSO's and told that he was to remain off-site for a 24 hour period by S30 lan at 10:30hrs.

10:35 When I was with Rob Personal and SSO's, I observed current <u>WOL</u> male known as **Sector 10:00** seated asleep in the Seniors Lounge. I advised Chris (Surveillance) and Perso was approached (under coverage) by SSO's Ian (S30) and Sandra (#93) and walked off the gaming floor, via Sante Exit at 10:40hrs.



## Other Incidents

10:45 When at Central Crown Club, Attendant Tupi Personal passed on details to RR and I regarding female known as a concerns raised by other patrons/staff re: offensive body odour.

Tupi told us that **Sector** may need to be spoken to in relation to this and would document concerns and pass them onto her manager's for them to communicate to relevant parties. I informed Quang **Perf**(CC Sft Mgr) as to discussion with Tupi and I also advised WJH. **Per** will ensure that details provided by Tupi will be forwarded onto WJH as to make appropriate recommendation.

Checks found that has not come under notice previously and her last rated play was recorded on 10/08/2006 playing EGM's in the West End of the complex.





## Self-Exclusion – Breach

10:55 Received a call from Simon (Surveillance), to attend Pit 9 Table 8 (BJ), as current Self-Excluded male was currently engaged in play. He advised that Simone Person, (Pit Boss) had contacted hi when the had bought in for \$10, 000 cash and had not provided a Crown Club Card, so a Suspect Transaction Summary was completed, using the transaction Drivers Licence as ID. When Persona had contacted Surveillance to obtain a photograph of Person, he was then identified as being Self-Excluded.

I attended and was met by SSO Nelson (#43) and VCGR Inspectors Allan **Personal** and Peter **Personal** arrived at 10:57hrs. **We was then walked off the gaming** floor, via Sante Exit and interviewed by the VCGR. He gave SSO Nelson \$7, 000 in chips to have cashed in at the Main Cage which was done and then he was referred to me to speak with.

told me that he applied for S/E 10 years ago and had not come in since applying at the old casino. He claimed that the reason why he was gambling this morning was because he had a break for a couple of hours, before catching a plane back to Launceston in Tasmania. He asked as to how he could apply to come back and gamble and the revocation procedure, along services provided through the CCSC were explained in detail.

He told me that he would most likely not apply and stay S/E at this stage. He accepted a CAPS's card and then left at 11:15hrs.



Checks found that applied for S/E on 21/04/1996 (10 years ago) and this is his first noted breach. Person has completed a TG Issue Log regarding the incident.



VCGR Inspector Allan Personal was informed.

14:08 When at Pit 8, Gordon Person (Pit Boss) advised that the had just got up from Table 10 (BA) and was making his way towards the Main Cage after sighting me. He advised that Person Michelle Personal Information had been the one to detect him and that Simon (Surveillance) had again been advised.

I then made my way towards the Main Cage and observed make his way off the gaming floor, via Sante Exit at 14:12hrs. SSO's were in attendance and ensured that he was walked off the property. International didn't wish to speak with the RGLO and VCGR Inspector Allan Personal was informed. Personal has completed a TG Issue Log regarding the breach.

13:05 Received a call from Tania (Sec. Comms) advising that she had Crown Club Attendant Ann from Carnivale Crown Club on the line, regarding male POI known as She advised that he had SYCO Account flagged and KOMMENT as follows:

I attended with Mark Personal and the was already at the Main Cage with VCGR Inspectors Sharon Personal and Simon Pers He was then walked off the gaming floor, via Sante Exit by SSO Sade (#145) and interviewed by the VCGR.

He was then referred onto me and I provided with Gamblers Help Information and encouraged him to contact the CCSC, if he felt the urge to breach, as to be discouraged for doing so. He told me that he is still driving taxi's and is not in debt, but still can't control himself from attending the gaming floor. He told me that he would consider looking into support service/s and proceeded to leave at 16:20hrs.



## Self-Exclusion - Breach

16:30 Received a call from Simon (Surveillance), wishing to advise that current Self-Excluded male had just attempted to have a card re-print at Carnivale Crown Club. Crown Club Attendant Patrick Personal with had entered details into SYCO and found account flagged and proceeded to contact Surveillance.

had then become suspicious of Patrick being on the telephone and proceeded to make his way off the gaming floor, via Western Porte Cochere Exit at 16:32hrs. No contact made by VCGR or RGLO. VCGR Inspector Simon Pers advised by Simon as to the breach. Checks found that this is the sime state of the breach since applying for S/E on 09/03/2006. He used to play in the Poker Room predominately.

## Self-Exclusion - Breach

**17:20** Received a call from Rhonda (Surveillance) advising that current Self-Excluded male **Control** had been located by GSUP, engaged in play at Pit 11 Table 5 (AR). Lattended and **Pers** was already at the Main Cage with VCGR Inspectors Sharon **Personal** and Simon **Pers**. He was then walked off the gaming floor, via Sante Exit by SSO Chris (#177) and interviewed by the VCGR.

He was then referred onto me and became quite argumentative about the revocation process and that he should be allowed back now, as he allegedly sent correspondence to PC and but had been advised that his application had been declined due to breaching. I asked what was it that he didn't understand about staying off the gaming floor for twelve months, to which he told me I can't stay away.

I explained the revocation procedure in detail again to **see and** he acknowledged that he understood all information provided and then left at 17:35hrs. A TG Issue Log has been forwarded by Nigel **Person** (Pit Boss) in relation to the breach.
