## Self - Exclusion - Inquiry

11:00 Received a call from male known as as to how he can apply for Self-Exclusion. The S/E procedure, along with the services provided by the CCSC were explained in detail and told me that he would most likely attend the CCSC today with a male friend known as $\quad$ who also wished to apply. claimed that they would most likely attend (31/07/2006) between 15:00-16:00hrs.

Checks found that neither $\square$ nor $\square$ have come under notice prior to 31/07/2006.


## Self-Exclusion - Inquiry / Other Incidents

11:15 Received a call from female known as calling in relation to her father known as problem". wished to be provided with information about what the CCSC offers and I explained the S/E procedure, along with the services of the CCSC in detail.

She told me that her father was currently overseas and allegedly was in "a lot of debt" that she claimed had now fallen into the hands of her family to clear up. She stated that her father would never voluntarily apply to $\mathrm{S} / \mathrm{E}$ and asked as to, who else has the power to exclude. I advised that the VCGR and CCOP have the power to exclude and that she would have to direct written correspondence to them, as Crown doesn't facilitate third party exclusion's.
then claimed that her father had been borrowing money from "various loan sharks" and as to who she should report this information to. I told her that such claim/s would need to be directed in writing to the GM S\&S PF. She told me that she would put something writing, as the family had allegedly been receiving "threats" and that consideration had been made in relation to involving VicPOL.

I then encouraged
 to consider attending Gamblers Help, or the CCSC in relation to support/strategies to assist with problem gambling. She asked that I advise appropriate parties as to the situation and provided all relevant personal information.

She asked if her father's "Mahogany Room Records" could be provided and I explained privacy and confidentiality protocols. She claimed that she may look into Legal advice regarding the situation her father has allegedly created. CCSC Mgr Perf advised as to incident details and separate e-mail sent to WJH/NG.

Usual checks found that has not come under notice prior to 31/07/2006. is currently a T200 (Mahogany) player and came under notice on 13/09/2003 as a possible associate or recipient of Teak/Maple Scam (refer to Patron ID

then placed a call (using his own mobile) to his daughter at 18:52hrs and thanked me for passing on the message. He told us that he would be returning home after 20:30hrs and he then resumed play at Pit 17 Table 19 (BA). I advised Paula Personal (Pit Boss) as to incident details.
then contacted me to advise that her father had just called her and that she wished to be provided with information about what the CCSC provides. She stated that he has been gambling a lot recently and not responding to phone calls and concentrating on gambling, rather than work and family. I explained the services available through the CCSC and she told me that she may attend in the future as to make further inquiries about support service/s.

## Other Incidents

19:00 patron attended the CCSC stating he wishes to be banned from the casino.

It was evident that perhaps did not have the mental capacity to fully understand the Self Exclusion process.

When asked, stated that he suffers from epilepsy and that he did not take his prescribed medication at 4:00pm. He appeared to be slightly agitated and somewhat confused. Water was provided when requested and he produced his medication (an assortment of tablets) from his wallet which he took.

The Self Exclusion process was discussed at length as were the possible ramifications of breaching a S/E Order. became agitated and concerned at the possibility of being prosecuted and receiving a fine if he breaches.

When asked if he understood what had been explained to him he stated that he rarely understands things.

DSM Glenn Person was requested to attend the CCSC and was subsequently briefed on the incident. A 14 day verbal exclusion was issued with the understanding that the CCSC will make contact with him on the 01/08/2006 and arrange for him to attend the Centre for a counselling session with a RGC in the company of a person that he wishes to nominate prior to proceeding with Self Exclusion.
