Ideally, we would like the joint advice concluded before all the directors give evidence about the State Casino Tax. But that may be impossible to achieve. (For example, one director - Nigel Morrison - is being examined in relation to the statement he made about the State Casino Tax next Tuesday 22 June 2021.)

If that is not possible for the other directors to have the written joint advice before they give evidence, as soon thereafter as possible. They will then be constrained in giving their evidence as you suggest. A decision has not been made in relation to the waiver of LPP but as you know the Commission may serve a NTP requiring Crown to produce copies of your written advice. Crown may well encourage the service of a NTP so that the Commission can have the benefit of the legal advice in its considerations of the issues.

The directors would also like to pay any underpaid State Casino Tax as soon as they better understand the issues and Crown's outstanding obligations.

The directors also are anxious to ensure strict compliance with RFI-002 and therefore seek your joint opinion on whether the current Crown disclosures concerning the State Casino Tax are adequate. See transcript of 7 June 2021, the concerns of the Commissioner and for example, section 120 of the Casino Management Act.

In terms of work product, it would be extremely useful if we could confer in conference as soon as reasonably possible after you have formed some preliminary views and then work out a time line for the provision of written advice.

I appreciate that you will be on vacation but many Counsel are likely to be away during the same school holiday period and your familiarity with Crown from the CUP work makes it more efficient for you to complete this work too.
