

Good morning Team,

This morning we received a call from Metropol Security advising of persons acting suspiciously on Level 6 Carpark in the back corner. The area was monitored and Mobile unit called to attend. Before the Mobile unit arrived, the vehicle was observed leaving the area. The vehicle then parked close to the entry to Level 6 entry and two occupants exited the vehicle and walked inside. The pair were then monitored entering BOH level 6 where they walked around momentarily and exited again.

The vehicle was not seen to leave the Level 6 Carpark, so Metropol Security was asked to check at Level 6 again. Metropol Security informed the vehicle was parked back in the same area, at the back of Level 6. The vehicle was then shortly observed leaving level 6 carpark and then the vehicle exited Haig Street exit at approx. 6:02am.

The male who swiped into the Level 6 BOH area is identified as Veng Anh female remains unidentified.

Is this something we would be interested in following up as a possible unauthorised person entering BOH? The only swipe made by the said employee as of midnight was at the Level 6 to BOH door, so I am unsure if he was on shift last night.
