Forensic Review and Controls Assessment – Engagement Variation – Hotel Card Transactions and Extension of Forensic Review Relevant Period

We refer to the engagement letter between Crown Resorts Limited (**Crown**) and Deloitte Financial Advisory Pty Ltd (**Deloitte**) dated 22 February 2021; and subsequent Variation letter dated 19 March, 2021, which set out the basis on which we will provide our services to you (**Engagement Letter**).

Upon Crown's request, and following agreement between Crown and Deloitte, the terms of the abovementioned Letter are varied to include the following:

i) Extension of Phase 2 and Phase 3 Relevant Period

The term **Relevant Period** is specifically extended to 30 April 2021. That is, the **Relevant Period** for the purpose of the Forensic Review, unless otherwise stated is 21 February 2014 – 30 April 2021.


ii) Additional Scope - Hotel Card Transactions



Fees

Based on the details of the matter as currently known, we estimate the work will require 2-3 staff, approximately 6-8 weeks to conduct and we estimate the fees to be within the range of \$300,000 - \$400,000 (excluding GST and expenses).

This is an estimate only and is based on the assumptions set out in the Engagement Letter, particularly those relating to availability and accessibility of information and Crown employees.

The estimated fee does not include any changes to the scope of the Work required to be undertaken which is caused by changes in the information provided, or the provision of new information not previously provided or additional Work outside the scope of Services as outlined above.
