Give the amount of emails and time to sort through advices which are often in discrete emails and not documents I attach summaries I prepared based on the advices on the law relating to gambling and its promotion and extradition/rendition as at the date of each table. I have concentrated on the main countries where previously we had offices. The only office now remaining is the Hong Kong Office which we are likely to be closing in the next couple of weeks. All employees in Hong Kong as per previous email from Mary are stood down and will soon be made redundant. This is of course still highly confidential.

As to Hong Kong there have been various updates regarding risk with the change of environment, the Hong Kong riots, the change in the Chinese government attitude since February 2017 being the date of the attached advice.

I trust this assists as a starting point and let me know what further information you may need.
