# Introduction

InvestiSec Consulting Limited was requested to conduct comprehensive background and database inquiries in China into:

- Jian-ping CHU (褚建平)
- Yuan-yuan YU (于媛媛)

In order to verify their bona fides and establish whether there is anything in their history that might inform a decision as to the propriety of entering into a business relationship with the subjects.

InvestiSec Consulting Limited conducted inquiries with pertinent database sources, to include regulatory, litigation and news media and public record databases.

The President of the ICBC branch advised that Chu has some reputation in the banking sector in Beijing, and he is a 'scholar' type with very good knowledge on Chinese banking system and policies, and meanwhile very experienced in the everyday banking business as he worked on almost all the positions of banks. The source has not heard of anything negative about Chu.

Regarding Yu Yuanyuan, most sources are unaware regarding her. The cash business manager commented that Yu Yuanyuan is currently the deputy General Manager of the Asset Management Dept of the Beijing branch of the PSBC, and she has been quite well regarded by the senior management of the bank, which could be seem from her being promoted to be the deputy GM of the Asset Management department as PSBC has put lot of attention and effort on the development of its asset management business in the last three years; she is quite outgoing, decisive (风风火火) and quite easy to work with. The source does not think Yu has much wealth and said Yu is just a bank employee.

Recently InvestiSec looked at PSBC for their IPO. It is unclear why the two individuals are being looked at – for a loan, to be hired etc. so InvestiSec has focused upon ethics and culture within PSBC for the clients' information.

The former branch manager of the Beijing branch of PSBC, an analyst from Guotai Jun'an and an official from the China Banking Regulatory Commission commented that PSBC has caught lots of attention since the arrest of Tao Liming in the anti-corruption campaign a few years ago, which delayed the IPO of PSBC, and the Central Leading Group for Inspection Work中央巡视工作领导小组(CLGIW) got into China Post Group, including PSBC, in July last year and announced that PSBC has high risk of corruption this January, which was thought to be a sign of more arrests.

The official from SASAC advised that from this stage it is really hard to tell whether there will be more people being detained or arrested, but it has been rumored that there are a few people from PSBC being investigated.

Desktop research revealed that PSBC operates current and fixed deposit, loans, domestic and international settlement, bill acceptance and discounting, bonds issuing, issuing agent, cashing agent, government bonds underwriting, government bonds and financial bonds trading, inter-bank borrowing, services and guarantee of foreign exchange, bank card and letter of credit, agency collection and payment and safe deposit box services.

As advised by the analyst from Guotai Jun'an and the former manager from the Beijing Branch of PSBC, PSBC, among all the Chinese banks, is probably the only one that has still been mainly focused on deposit business, which counts for around 10% of the market, and PSBC has a NPLR of 0.9% that is far less than the industry average because PSBC has always been quite conservative in the business. The analyst from Guotai Jun'an commented that this focus was probably due to its background and its close connection with China Post, and PSBC was established as a subsidiary to China Post for the convenience of money transfer, and most PSBC branches are in the branches of China Post, and PSBC did not separate its business from China Post until 2004/2005 when the State Council decided to reform China Post and separate the post business and the banking business, then PSBC was formally established in early 2007 as an independent bank.

area, where other banks do not have presence, and this kind of business development had brought huge amount deposit and related business to PSBC but affected the management team of PSBC, and most the senior people in PSBC, including the CEOs of branches, do not have any background or experience in banking industry, and many mid to high level managers used to work in China Post and do not have basic banking business knowledge or experience either, and if PSBC would really like to become a 'real' bank, it needs change all these people.

The former legal manager of PSBS commented as well that most CEOs of the provincial branches of PSBC were from China Post and did not have banking background, and this has started to affect the business expansion of PSBC because in many meetings these CEOs just had not idea about banking business at all, and they could be on the current position because they had worked in China Post for very long time.

All the sources mentioned the corruption of Tao Liming, the former CEO of PSBC.

The official from the SASAC commented that PSBC had quite serious corruption issue, mainly embezzlement, and Tao Liming was not the only one and a few other people related to him were arrested as well. According to him, it has been quite common for the senior people in PSBC or its branches to reimburse personal spending from the bank.

The civil servant from the CBRC advised that many heads of the branches of PSBC were found out to have involved in lending illegally to other financial institutions, embezzlement and getting loan for other people and charging kickbacks.

However, a journalist advised that comparatively PSBC seems to have a lot less corruption issues than other banks, and PSBC had always been taken as a conservative and deposit-focused bank.

According to the former head of the PSBC branch, the former branch manager from the branch of PSBC in Guangzhou and the official from CBRC, PSBC actually had less corruption than other state banks, and an important reason is that the employees and the management of PSBC, technically, are not as capable as the employees of other banks.

The former head of the PSBC branch further commented this is ironic but true, and many financial crime and financial corruptions were carried out through very careful design or structuring to avoid being found out while the managers of PSBC, who did not normally have financial background, did not know how to do this; also, generally speaking most people in the current senior management of the PSBC, including all the PSBC branches, had no financial background and are not as bold as the senior managers of other banks in many ways, including the development of new business and new products, and it could be seen that the business range of PSBC is comparatively simple than all the other banks, and this, to some degree, avoided the pervasiveness of corruption.

The official from the CBRC advised that the reported corruption or financial problems of PSBC are indeed less than other banks, and overall the business of PSBC have been conservative comparing to other banks; also PSBC had a quite strict internal compliance, including a joint responsibility mechanism and reporting system, and no matter what kind of issue, once reported to the management, the head of the branch would take responsibility as well, and if it is corruption issue, the case would be transfer to the local procuratorate straightaway, rather than internal investigation first.

The former branch manager of the PSBC branch in Guangzhou commented that compared to other banks, PSBC had a lot less corruption issue or financial crime, and besides the technical
