#### **DIRECTOR AND SECRETARY CHANGES**

With effect from 1 January 2021, Barry Felstead and Joshua Preston resigned as director and secretary, respectively, of the Company.

Furthermore, on 11 February 2021, Andrew Demetriou resigned as Chairman and director of Company.

In order to fill the vacancy on the Board and having regard to Article 14.1 of the Company's Articles of Association which requires that the Company must have at least five directors, it is proposed that Xavier Walsh (CEO of Crown Melbourne) be appointed as a director, subject to the receipt of any necessary regulatory approvals. The Company has received a signed consent to act from Mr Walsh. While Mr Walsh is already an approved associate of Crown Melbourne, as a precautionary measure, it is proposed that his appointment as director be made subject to the receipt of any necessary regulatory approvals.

#### **PROPOSED RESOLUTIONS**

- the resignation of Barry Felstead as a director of the Company be noted;
- the resignation of Joshua Preston as a secretary of the Company be noted;
- the resignation of Andrew Demetriou as a director of the Company be noted; and
- Xavier Walsh be appointed as a director of the Company subject to the receipt of any necessary regulatory approvals.
